1) Chairman's Report for 2025

- Membership number up

- Speed Championship had a very successful year 64 competitors well over 30 events

- The club made a small profit in 2025 of circa £550



4) Specific Events / Expenditure for 2026

* 2026 Summer Raffle or similar in aid of Salisbury Hospice

In 2025 we raised circa £300 for Salisbury Hospice by the generosity of our members. We will have a similar raffle event. *Unanimously accepted*.

* DMC to progress the organisation of a DMC Practice Day at Clay Pigeon (early March)

This generated a lot of debate. Concerns raised by the membership

- Clay Pigeon as a venue The meeting would prefer Llandow or Castle Combe as the location for a practice day.
- yes, a different venue would be more expensive but same MSUK costs and admin overhead
- time of the year March would not be a preferred time (plus CP is very exposed location)
- the financial and reputational risk for the clubs first venture with motorsport UK approved event was raised (i.e. same level of risk for any circuit)
- the meeting thought the safer option for our first MSUK a event would be jointly organised with another club.... BDCC for CP or Wildlife for Wiscombe, Bristol for Castle Combe
- our 2026 Club structure would have to change new formal head marshal and safeguarding officer roles (approved and certified by MSUK)
- concerns raised who would take responsibility for organising practice days / competitions.
- * DMC to help with the organisation of an event at Wiscombe Park (5 Clubs or Wildlife)
 - This was accepted by the membership subject to further evaluation.
 - Wildlife seems to be the preferred option
 - There was some debate about encouraging support for other events by awarding Championship points for Marshalling. No decision would be made without further consultation with the membership.
- * Continue advertising at Gurston Down (Est cost of £200 for the season)
